A major is an organized curriculum that is part of an existing degree program. A major must be associated with the degree program under which it is offered and must share common core courses (and usually shares prerequisite courses) with all other majors in the same degree program. 1. Proposal Structure

- a) Rationale
 - Describe the proposed program, identifying what value would be added by its establishment.

The College of Music is requesting approval for a new major in Community Music as part of the Bachelor of Arts in Music degree. The field of Community Music (CM) is a rapidly expanding focus area for musicians, scholars, and community practitioners worldwide. The modern CM field encompasses a broad range of participatory music making practices aimed at fostering community development and engagement, with CM researchers and practitioners working in a variety of community-based settings including, but not limited to: prisons, shelters, afterschool programs, community centers, senior homes, places of worship, non-profits, and public orchestras and ensembles. Supported by institutions such as the International Centre for Community Music (York, St. John University) and journals such as the International Journal of Community Music, Community Music is a well-established academic discipline, with most existing programs located in Canada and the United Kingdom.

The FSU College of Music is the most prominent music program in the state of Florida, due to its size, prestige, long history, and increasingly diversified approach to career preparation. The extensive network of College of Music alumni plays an active and vital role in shaping music making and music education throughout the state and the nation. The college also has a rich tradition of serving the region and state through community partnerships with programming both on- and off-campus. Recently, many students and alumni have expressed an interest in meaningful community engagement as part of their curricular activity, the growing interest partly attributable to rapid social change over recent years, as well as an expanded focus on creating musical opportunities for all people, regardless of race, gender, sexuality, religious background, or socioeconomic status. Collectively, these conditions both inspire and support our mission to create this new and innovative curriculum at this time.

The purpose of the new major in Community Music is to allow students with a diverse set of skills and backgrounds in music to pursue a liberal arts interdisciplinary degree program that will allow them to make a difference in the communities in which they live, through music. We have identified the existing Bachelor of Arts in Music degree as the ideal home for this new emphasis in Community Music, and the degree structure can accommodate a flexible curriculum allowing students to pursue diversified interests and

pursue coursework in multiple supporting fields such as entrepreneurship and arts administration.

During the 2023–2024 academic year, the College of Music convened a BA Community Music task force that devoted many hours to researching, discussing, and designing the new major. Colleagues from the College of Social Sciences and Public Policy, College of Social Work, representatives from community music organizations, and supporters of music in Tallahassee have had a substantive voice in developing of the proposed program. Also during AY 2023–2024, the College of Music made room for Community Music in its faculty and staff structure, creating a new "Community Engagement Manager" staff position, and recruiting a community music scholar as Assistant Professor of Musicology/Les and Ruth Akers Endowed Chair in Community Music.

The major is designed to offer coursework that builds experience in facilitating music-making in a wide variety of social settings, and develops relevant skills in entrepreneurship, community leadership, program development, advocacy, grant writing, and administration. The program is centered on student engagement with a variety of community partners via observation, supervised participation, service-learning opportunities, and leadership, modeled after the experiential learning components of our existing music education (BME) and music therapy (BM) majors. Graduates will be equipped to pursue a wide range of arts-related careers and may choose to pursue graduate studies in a related field.

The College of Music is excited to place community and community-engaged music at the core of this major, contributing to its strategic vision of "creating a culture of community that creates, experiences, and appreciates music together." With the first Bachelor's program dedicated to Community Music in the United States, FSU is slated to become a major North American center for training and research in this area, attracting students, faculty, and guests interested in contributing to the growing knowledge of Community Music practices and approaches. Additionally, the BA Community Music major aligns perfectly with FSU's strategic plan goal #3: Nurturing and Inspiring FSU's Entrepreneurial Spirit, "creating endeavors for the public good," and expanding "opportunities for students, faculty, and staff to evoke creativity, innovation, and entrepreneurship in scholarly activities, research, artistic endeavors, and institutional operations."

- ii) Identify particular features that differentiate it from existing majors
 - Accessibility to a broader pool of applicants. This will be the first undergraduate
 major in the College of Music that does not require a performance audition.
 Additionally, we will accept applicants who specialize in instruments and
 musical styles not otherwise included in our existing programs.
 - Inclusion of three new courses (9 hours) designed specifically for this major
 - Requirement of 6 hours coursework in Social Work and Art Education
 - Differentiation of 12 hours in the core music coursework between BA Music-General and proposed BA Music-Community Music to account for a less performance-intensive focus

The college's current BA offerings include four areas of emphasis, each with a strong focus on music performance: Commercial Music, Jazz, Sacred Music, and

the General Emphasis. The new Bachelor of Arts in Community Music major not only complements these offerings, but also signals a progressive understanding of 21st century career opportunities in music. This new major will be unique not only to the College of Music's program inventory but will also be among the first of its kind in the United States at the undergraduate level. It is an innovative curriculum that will deepen the College of Music's connection with the surrounding region as well as a global network of CM practitioners.

iii) Identify common core and prerequisite courses shared with existing majors.

The four existing BA Music majors (General, Sacred Music, Commercial Music, Jazz) each require 40 hours of core coursework in music, of which the Community Music major will share 28.

iv) Identify the target group for the program and the need to serve that target group.

There are multiple target groups for this major. It is important to consider that nearly all students pursuing a degree in music declare the major at the beginning of their academic careers.

- Prospective undergraduate music majors with an interest in becoming community music practitioners, leaders, and administrators.
- Established community musicians and practitioners who would not be likely to apply to a traditional music performance or music education degree due to audition requirements or because they are trained on instruments other than those typically accepted.
- Current or prospective undergraduate students in other disciplines outside of music who may consider a double major with the BA Community Music.
- Current undergraduate music majors in the BA General Emphasis who are seeking a more defined course of study and would prefer to focus on study of Community Music and related skills.
- v) Identify target semester for implementation.
 - We plan to implement the new major in Fall 2025.

On the basis of required coursework, there are two distinctions from the four existing BA Music majors:

- the requirement of three new courses (9 hours) in community music
- the requirement of two courses outside the College of Music to fulfill major requirements.

These additions are offset by a reduction in core music coursework that is shared across the other four majors. Thus, the unique content is estimated to be 15 hours of the total 120, or 12.5%.

BA Community Music majors will be advised and mentored by a supervisory committee that represents the interdisciplinary nature of this major, comprised of faculty and staff in community music and entrepreneurship, as well as representatives from the College of Social Work and partnering community organizations. Each student must propose a provisional plan of study, comprised primarily of a list of eligible courses, to the Advising Committee for Community Music by the end of their second semester in the major based on the major requirements as listed above and with reference to the list of approved courses.

The application process will involve a portfolio submission and an interview to assess the applicant's musical abilities in various formats as well as their written and spoken communication skills. The BA Community Music major will be the first undergraduate degree in the FSU College of Music that does not require a traditional performance audition for admission. This approach aligns with recent positive trends among NASM-accredited institutions to expand access to applicants with varied musical preparation and experience.

Bachelor of Arts in Music - General Track

Students are responsible for making successful academic progress and completing their degree programs. To avoid delays, it is imperative that students attend advising sessions regularly and understand degree requirements.

Musicianship & Performance

Music History

Students must complete all 4 courses of the music history sequence which includes:

MUH 2512 (Music in World Cultures)

MUL 2110 (Survey of Music Literature)

MUH 3211 (Survey of Music History-Antiquity to 1750)

MUH 3212 (Survey of Music History-1750 to Present)

These courses must be taken in order, but do not have to be taken back-to-back. Students must complete MUT 1112 (Music Theory II) before taking MUL 2110.

With permission from the Assistant Dean of Undergraduate Studies, students may substitute MUH 2051 (Music in World Cultures for Non-Majors) for MUH 2512.

Applied Music

Applied music lessons (private lessons) with a professor or graduate student on the student's primary instrument must be taken every fall and spring until degree requirements are satisfied. Students may be required to perform juries or final examinations as determined by their studio.

Ensembles

Students must complete a minimum of 4 ensemble credits. Each ensemble has 2 interchangeable course codes: MUN 2__ and MUN 4__, with 2 ensembles being taken for credit at each level. Ensembles taken for 0 credit do not fulfill degree requirements.

Students receiving music scholarships must participate in an ensemble each fall/spring semester as listed on their music scholarship contract. Scholarship compliant ensembles may be taken for 0 credit and still fulfill scholarship requirements.

Chamber Music

- Woodwind and Brass principals register for MUN 2460/4463 (Chamber Music) their **1**st **spring** and **2**nd **fall** semesters.
- String principals register for MUN 2460/4463 (Chamber Music) their <u>1st fall</u> and <u>2nd fall</u> semesters.
- Percussion principals register for MUN 2140/4443 (Percussion Ensemble) for 2 semesters.
- Piano principals register for MUN 2510/4513 (Piano Vocal/Instrumental Accompanying) for 2 semesters.

Student Recital Attendance

Students must complete 6 semesters of MUS 1010 (Student Recital Attendance). To receive a grade of "Satisfactory," students must earn 15 recital credits by attending college-approved events. Some events may be worth multiple recital credits. Transfer students should consult their advisor regarding the required number of semesters.

Upper-Division Music Electives

Students must complete 12 credits of upper-division music elective coursework. Upper-division music electives are defined as courses at the 3000 or 4000 level not already required by the degree. Students often fulfill these credits by continuing lessons into their third and fourth year, taking advanced music theory courses, or other similar electives. Students can consult their advisor for further recommendations.

General Studies

Satisfactory completion of 36 credits of general education courses within the Liberal Studies for the 21st Century program. For more details about each of these requirements, please see: *It's All Academic 2022*: https://undergrad.fsu.edu/academic-information/its-all-academic

Ouantitative & Logical Thinking (Math)

Students must complete a total of 6 credits in this area including 3 credits from a State Core course with a prefix of either MAC or MGF, and 3 credits of a Quantitative & Logical Thinking course of their choice. This requirement must be completed with a grade of C- or better within the first three semesters of undergraduate study, not including summers.

English Composition

Students must fulfill a total of 6 credits in this area: ENC 1101 and ENC 2135. The courses must be completed with a grade of C- or better within the first two semesters of undergraduate study, not including summers. Students transferring to FSU with a completed AA degree from a public Florida institution are exempt from taking ENC 2135. All other transfer students should consult their advisor.

Social Science & History

Students must complete 6 credit hours in the combined area of Social Science and History. Three of these credits must come from a State Core course. Since 3 credits for History will be covered by MUH 3211 (Music History I), students must therefore complete 3 credits of a Social Science State Core course. Options include:

- ECO 2013 (Macroeconomics)
- POS 1041 (American National Gov.)
- PSY 2012 (General Psychology)
- SYG 1000 (Intro to Sociology)

Humanities & Ethics

Students must complete 6 credit hours in the combined area of Humanities and Ethics. Since MUH 2512 (Music in World Cultures) and MUL 2110 (Survey of Music Literature) fulfill the Humanities requirement, students should complete the only Ethics State Core course: PHI 2010 (Introduction to Philosophy).

In addition to the above 6 credits, students must complete 1 credit of a Natural Science Laboratory, either as a separate laboratory course designated by the course suffix "L" (e.g., BSC 1005L) or as a combined lecture/lab course designated by the course suffix "C" (e.g., CHM1020C).

Writing "W"

Students must complete two Writing "W" courses. The first of these course requirements is satisfied through MUH 3211 (Music History I) with a grade of C- or better. Students are advised to combine the second Writing "W" course with a Diversity course.

Students must complete two "SIP" or "FE" courses: one of each or two of a kind. The first "SIP" requirement is fulfilled with MUT 2216 (Music Theory III) with a grade of C- or better. The second requirement can be fulfilled through an internship, senior recital, project, or thesis, a DIS (Directed Individual Study), or any course with the "SIP" or "FE" designation. Students can also fulfill the second "SIP" or "FE" requirement through the Career Center's Experience Recognition Program. See advisor for details.

Diversity

Students must complete two Diversity courses in total. One Diversity course is fulfilled with MUH 2512 (Music in World Cultures) or MUH 2051 (Music in World Cultures for Nonmajors). Students are advised to combine a Diversity course with a Writing "W" course.

†Foreign Language

All university students who receive a BA degree from FSU must demonstrate proficiency in a classical or modern foreign language through the intermediate level. Students can satisfy the foreign language requirement with coursework through the 2000 level (2220 or the equivalent course) or with an equivalent CLEP or language placement test score. If the foreign language requirement is satisfied via testing, those credits must be replaced with additional non-music electives. Foreign language courses may be taken on an S/U basis. Non-Music Electives

Students must complete a minimum of 21 non-music elective credits. Students often fulfill these credits with additional majors, minors, specialized studies, or certificates. Upper-Division Credit Total

Students must complete a total of 45 credits of upper-division coursework. Upper-division coursework includes all courses at the 3000 or 4000 level, both music and non-music courses. Students are encouraged to seek non-music electives which also fulfill upper-division credits.

The General Education and Elective courses must be selected to satisfy all area and diversity requirements unless your program meets these requirements with major courses. Milestones are courses and special requirements necessary for timely progress to complete a major. Missing milestones will result in one of two types of map registration stops. The first level (Degree Map Off-track) is placed following grade posting if the student has missed a milestone (course and/or GPA) for the first time in the major. If a student is in non-compliance with milestones for two (2) consecutive semesters (excluding summers), a Major Change Required stop is placed on the student's registration.

All entering students must complete a supplemental application and submit a portfolio to be granted admission to the College of Music.

In support of the newly created Bachelor of Arts in Music/Community Music major in the College of Music (COM), the College of Social Work (COSW) will offer an agreed upon number of seats in **SOW 4104 Human Behav. & the Social Environment** to accommodate students in the new major starting Fall 2025. The COSW will also offer assistance in placing students in the new community music major in additional courses as is appropriate based on advisor communication.

The COM will communicate in a timely manner regarding the number of seats needed and immediately inform the COSW of any changes in needed seats prior to the second day of drop/add to ensure maximum enrollment numbers in these courses are not negatively impacted.

In support of the newly created Bachelor of Arts in Music/Community Music major in the College of Music (COM), the College of Fine Arts (COFA) will offer an agreed upon number of seats in **ARE 4932 Intro to Arts Administration** to accommodate students in this new major starting Fall 2025.

The COM anticipates 5 to 10 seats in ARE 4932 each academic year. The curriculum map places this course in the spring semester of the second year of study, however students may elect to enroll in this course in other semesters. The COM will communicate in a timely manner regarding the number of seats needed and immediately inform the COFA of any changes in needed seats prior to the second day of drop/add to ensure maximum enrollment numbers in these courses are not negatively impacted.

If demand from BA Community Music majors exceeds the aforementioned enrollment projection and necessitates the creation of additional sections of ARE 4932, the College of Music will cover the costs of hiring adjunct instructors to teach those additional sections.
